Business Manager's Report

I am pleased to report that our work has been good this year in Local 181's jurisdiction, despite the record breaking rainfall. The work hours are up 5.11% for the first eight months of 2016 compared to the first eight months of 2015.

The Local 181 treasure, Health & Welfare Fund, and Apprenticeship & Training Fund all remain financially sound.

I would like to congratulate and wish the best to Linda Minton, Health & Welfare Administrator, on her recent retirement and thank her for all the hard work she has done for our members.

I would also like to welcome Stacey Ausenbaugh as the new Health & Welfare Fund Administrator; I feel confident Stacey will do a good job!

The Health & Welfare Fund Trustees have implemented some changes to your benefits effective January 1, 2017. The announcements were mailed to the members from the Health & Welfare Fund the last of August. If you did not receive the announcements, please contact the Health & Welfare office.

The Apprenticeship & Training Sites at Boston, Kentucky and Lynnville, Indiana have been very busy this year. The construction on the new classroom at the Lynnville Site is scheduled for completion in April 2017. The tower crane at the Boston Site is complete and is operational. This is a big asset to our program. I encourage everyone to utilize both of our training facilities.

The General Election this November is very important to all union members across the nation. The U.S. Senate and U.S. House both have a majority of members who are anti-labor. If an anti-labor President is elected and Senate and House remain majority anti-labor, we will be faced with a National Right-To-Work law. The Presidential polls indicate that Hillary Clinton or Donald Trump are the front runners to be the next United States President. I would like to share a quote from each candidate. Hillary Clinton stated, "I will not let anyone undermine collective bargaining rights, and I will not let anyone undermine prevailing wages or project labor agreements". Donald Trump stated, "My position on Right-To-Work is 100 percent".

In Kentucky the Governor and State Senate majority are in support of Right-To-Work. If we don't keep and elect labor-friendly candidates to the State House, Kentucky will become a Right-To-Work state and next there will be repeal of prevailing wages.

At the present, Indiana has a Governor and majority of the State Senate and State House who are all anti-labor. This November we have the opportunity to elect a labor friendly governor. John Gregg has committed to stand with labor. This year's election is very important to the working families in Kentucky and Indiana. There is a list of endorsed candidates by your Executive Board later in this issue. Please look at where the candidates stand on the issues that are vital to the livelihood of our union before you vote.

The 2016 Local 181 Family Picnic held at Huber Orchard and Winery in Starlight, Indiana was well attended by our members and their families.

The holiday season will soon be approaching and I would like to take this opportunity to wish each and every one of you a Happy Thanksgiving, Merry Christmas, and Happy New Year.

The work in District One has been good this summer. This year's rain has hurt our dirt work, but overall it has been a good year.

Charbon Contracting, J.H. Rudolph and Rogers Group have picked up a number of jobs thoughout the District. Peyronnin Construction is continuing work at the Calhoun Water Treatment Plant in McLean County. In Henderson County, Danco is the General Contractor at the Henderson Municipal Services Center with Hazex Construction preforming the site work on that project. PPMI has picked up a nice job at Gibbs Die Casting which should last until the first of next year.

Goettle has several operators at Big Rivers Power Plant in Sebree, which should also last until the first of next year.

In Union County, Deig Bros has been awarded Phase 2 of the Storm & Sewer Separation project in Morganfield. This project should last until spring of 2017. In Daviess County, Danco has been awarded the General Contractor on the Owensboro Middle School track/football field renovations. Hazex has the site work as well. In addition, Blackhawk Foundation has picked up work at the Independence Bank in Owensboro.

In Muhlenberg County at TVA, Kiewit Power still has a good number of operators working at the Natural Gas Combined-Cycle Generating Power Plant with the projected finish date in June of 2017. G-UB-MK continues to work several operators at TVA Paradise.

Trans Ash has picked up more work at TVA, with several operators working for them. Spirtas has started their demolition of the Coal Wash Plant in Paradise which should take until spring of 2017 to finish. There continues to be talk of several good projects in upcoming

months at TVA.

In Hancock County, at the Aleris Aluminum Plant, Advantage Industrial Systems is working on the expansion with the second phase starting. In Warren County, we have a large project ongoing at the Corvette Plant in Bowling Green with the expansion of the new paint shop. At WKU, Whittenberg continues to work on their project at the WKU Science Building.

In closing, we at District One would like to encourage the members to update their skills list and to keep all certifications and drug cards up-to-date "Help us help you."

At this time we would like to congratulate and thank everyone for the huge turnout at the Labor Day Parade in Boonville, Indiana. By estimation the operators had well over 300 in attendance. The overall event was a huge success.

Work in District Two has been good for several

years, with this year being no exception. However, dirt work has been slower than normal with all of the rain. The State of Indiana has not released any new work the first part of next year. Building work has been well above average for the last three years.

The Double Tree Hotel project is going well at this time with Maxim Crane, Koberstein, Klenck Companies, Blankenberger Brothers and Precision working on this job.

Blankenberger Brothers has various jobs in Evansville and the surrounding area with 67 operators working. Deig Brothers is working on the Maryland Street Bridge in Evansville and other jobs in the Evansville area with 32 operators at this time.

At Gateway Hospital we have Skanska, Klenck, Koberstein and Danco working. Also, Skanska, Central Rent-A-Crane, UCCI and Graycor are working on the SCR at AEP.

Sterling Boiler has an outage at Culley Station and also work at AGC Power Plant, Duke Energy and A.B. Brown. Blankenberger Brothers also has the Ash Cell Project going on at A.B. Brown. Skanska has work at Duke Energy, Cogen, Astra Zeneca and SABIC. Skanska has 61 operators and Sterling Boiler has 18 operators.

Bowen Engineering has work at Duke Energy and IP&L with 37 operators. UCC, Union Tank and BMWC are working at IP&L with 11 operators total.

Miller Pipeline is doing service work in Evansville, Jasper and Bedford, Indiana with 21 operators.

Sevenson Environmental is dredging two holding ponds at G.M. Foundry in Bedford, Indiana with 21 operators. At this same location Renascent is building a Water Treatment Plant with two operators.

McIntyre Brothers is at the G.M. Foundry and also on various projects for Duke Energy. McIntyre has 11 operators working.

On highway projects we have Ragle working n Orange and Martin counties replacing three

bridges. Ragle has work on I-64 and a railroad bridge near Taswell. Ragle has 28 operators. Crider and Crider has a box culvert and road elevation job

near Springville and are building an entrance road to Bedford Industrial Park with 18 operators. Cal Car has paving projects in Orange, Crawford and Dubois counties with eight operators.

Turner Construction is stripping at Lehigh near Mitchell with 13 operators.

Sieboldt Quarry has been shut down due to overstocking. The operators have been dispersed to other sites this summer. I-69 has brought a few members back and stockpiles are beginning to go down. Mitchell Crushed Stone has full employment with 17 operators. American Contracting has a bridge replacement in Dubois County and two bridges on SR 64 and Hwy 37 near English, Indiana. American has seven operators in District Two.

J.H. Rudolph set up an asphalt plant in Petersburg for work they have going on from Otwell to Washington. Rudolph has various jobs in Evansville and surrounding counties with 36 operators.

E & B Paving has work in several counties in District Two with jobs on I-64, Highway 41 and various roads in the district. E & B also has two slide jobs in Spencer County. Ryan Inc. Central is

building a cell at Laubscher Meadows Landfill with 20 operators working. Lutgring Brothers is stripping at Cape Sandy and other places. Lutgring has 17 operators working.

On the political side we have a major election coming up on November 8, 2016. It will be a presidential election and a gubernatorial election for the members of District Two. Indiana has no prevailing wages, except for Davis-Bacon and Indiana is now a right-to-work state. If we lose the presidential election we will very likely lose Davis-Bacon wages. If we lose the presidential election, we could have a House, Senate and President of the same party with no checks and balances.

Brothers and sisters, remember it is your right and duty to vote. Please vote wisely for candidates who do not wish to do harm to working men and women. Please vote on November 8th.

We feel fortunate and blessed to report that work in District Three remains at an unprecedented high.

The Downtown Bridge is in its final stages. Walsh has only one bridge deck left to pour with focus concentrating on finishing the slopes and ditches. The Asphalt crews are pushing to keep up with the Site crews to cover the ramps for the upcoming lane changes. Milestone is nearing completion of the south bound approaches of 1-65 on the Indiana side and putting the finishing touches on 10th Street. James H. Drew has several crews working to complete all signs, lighting, and traffic signals. The Kennedy rebuild has finished the concrete deck pours and are working on pouring the barrier walls.

Work on the East End Bridge is progressing

Work on the East End Bridge is progressing on schedule with the last section of bridge deck having been set in place at the end of August. The 1700 Drumanard Tunnel is complete with fire suppression and lighting to finish shortly. Milestone has nearly completed the concrete

paving on the Kentucky side, and Bloomsdale Excavating is finishing the punch list items on the Indiana side.

F.A. Wilhelm is going vertical with the concrete package at the Omni Hotel, and will be starting construction on another hotel and parking garage in downtown Louisville in the near future. Their joint Metro Sewer Department venture with Walsh at Logan Basin continues on schedule.

E & B Paving work has been very busy throughout the summer. The grade and drain work at UPS Centennial is near completion. Work on I-65 between Sellersburg and Henryville, Indiana is coming together with soil stabilization complete and paving has started on the south bound side. The paving project on Highway 60 from Sellersburg to Pekin, Indiana is complete except for striping.

Also in Indiana, Milestone is continuing to work on Hwy. 31 between Seymour and Walesboro with continued efforts on the bridge over Big Sandy Creek. Their work on McDonald

Lane is in the final stages with paving and sidewalks being installed. Milestone also picked up work in New Albany, IN for a walk path along the Ohio River.

The bourbon industry has resulted in several jobs in Louisville. Sullivan & Cozart are still working in downtown at the Whiskey Row site, refurbishing the existing brick façade while their work at Angels Envy Distillery is near completion. Abel Construction has ongoing work on a new still house and fermenter building in downtown Louisville and a warehouse in Bardstown, Kentucky for Heaven Hill Distillery.

There are several contractors working at North American Stainless in Carroll County. Whittenberg is nearing completion of their concrete packages. Baker Concrete should be finishing any day with the wall package. Atlas is also within a month of setting all the new equipment inside of the new addition.

With the upcoming election drawing near, we encourage all members to do your part to put labor-friendly politicians in office. Please make an effort to attend the District meetings on the 1st Tuesday in Louisville, KY and 2nd Tuesday in Elrod, IN.

Maxim has had two tower cranes on site in downtown Lexington for about 2 years, and the rumor is they are about to commence work on the Centre Point project. Force Construction has had several operators on an expansion to the Toyota Tsusho plant in Georgetown. Work at the Bluegrass Army Depot continues with a small crew of operators there for Safway Construction. Aquarius Marine is finishing up the Lock 8 work in Jessamine County. Ryan Inc. Central has a couple of landfill projects in Franklin and Scott Counties.

Kentucky State Transportation Cabinet has proposed lettings, in the next few months, that contain some nice projects in District Four. They propose to replace the Kennedy Bridge that crosses Lake Herrington between Mercer and Garrard Counties. They also propose to let the first of many projects on the Highway 127 corridor in Russell County. The main purpose of these projects is to take the traffic off of the Wolf Creek Dam.

We have an election coming in November that could be the most important election in your lifetime. We have the election of all 100 members of the Kentucky House of Representatives. One party controls the House and another party controls the Senate and the Governor's office. The House is the only thing that stands between our members and the RIGHT-TO-WORK (RTW) being passed in Kentucky. Along with RIGHT-TO-WORK, some candidates want to eliminate PREVAILING WAGE legislation. The facts are clear, workers in RTW states earn less and have more job related injuries.

I know that voting is a personal decision, but please take a look at the candidates and make your decision on who is best for you and your family.

Work in District Six has been very slow but is looking much better for next year. I would like to give a "thumbs up" to all the members who took advantage of their time off to utilize the training facilities to improve their skills. The additional NCCCO Certifications, Pipeline, and other training received helps Local 181 and makes the member more employable. Local 181's training sites have acquired several pieces of equipment; please take advantage of this new equipment.

Marathon's work at the refinery has been very slow this year but is improving at this time and looks to be very good for the upcoming year with Turner having two major shutdowns scheduled. Turner is also acquiring some civil work at this time that should last a while and require additional operators. Maxim's work at the refinery is also looking better and should be very good next year. Hopefully work will return to normal levels for them. Global, J & J, and Rick Eplion Paving continue to use several operators,



and their work should also improve.

Marathon Ashland Petroleum (MAP) has added a DISA Security background check in order to work at their facility. If you wish to work at MAP and do not have the DISA background check, bring your Lead and TWIC card to the District Six office. We will get your background check for you.

Ryan, Inc. Central bid work at the Big Run Landfill in Boyd County and the Advance Disposal Landfill in Morehead and were successful on both projects. The Big Run job is finishing up at this time with Advance Disposal just getting started. The Big Run Landfill project has several operators working this summer. Russell Bridge is scheduled to be open to traffic by Thanksgiving with demo of the old bridge to begin in December 2016. We continue to pick up some work at the MSU campus in Morehead and hope to see more of that work be awarded to

union contractors. Clay's Performance has work at Special Metals and other sites in our area with two or three operators at this time. This is one of our new contractors, and we hoping they will be awarded more projects.

Work at the AEP Big Sandy Plant has been very good and will continue for some time. Enerfab has finished the gas changeover and continues to have some maintenance work on site. Independence Excavating is in phase one of the demo work which consists of the coal yard and one of the cooling towers. This job should last until February 2017 employing approximately 10 operators with the second phase being bid soon. Entact was awarded the work on the ash pond; this job has just begun and should last about five years employing over 20 operators.

Pipeline work in our area is going good with Michels and Contractor's Rental Corp. working several operators and is expected to last the rest

The road work is staying steady with Hi-View having jobs in Floyd and Pike counties and continuing to bid on jobs in our area. Kokosing is nearing completion of their job in Pike County but was awarded additional yardage that will add a little more time to the project. To provide our contractors an opportunity when bidding on these projects we must keep prevailing wage in our

Thanks to all those who helped with the Catlettsburg Labor Day Parade. There was a great turnout with wonderful weather this year. As always, we at District Six are here to help with anything you may need. Don't forget to re-register every six months and attend your monthly union meetings.

Hello to all! With fall upon us, I hope everyone is enjoying the cooler temperatures and all of the fun activities that are associated with this time of year: bonfires, apple orchards, corn mazes, and pumpkin spice in everything!

I would like to take a moment to introduce myself as the new Administrator of Health & Welfare. My name is Stacey Ausenbaugh and I have worked in the fund office for over six years. I have probably talked with many of you regarding contributions, eligibility, and HRA claims in the past. I am very excited about my new positon and I hope I can be of assistance to any members with concerns or questions.

As mentioned in our last newsletter, Linda Minton is

leaving her position as Administrator to begin enjoying her retirement and spending time with her family. I would like to thank Linda for continuing to work, as needed, over the past several months. She is doing a great job assisting me during this transition.

Benefit Changes for 2017

Prescription Drug Benefit-

Effective January 1, 2017, the Prescription Drug Benefit shall be amended as follows:

Annual Prescription Out of Pocket Maximum

Per Member \$1,650 Per Family \$8,300

Once the Member and/or family Prescription Out-of-Pocket Limit is satisfied, no additional co-payments or coinsurance will be required for the Member and/or family for the remainder of the calendar year.

Your prescription co-payments will remain the same:

Retail - (one month supply) is \$20.00 for generic, \$35.00 for Formulary Brand, and \$50.00 for Non-Formulary Brand.

Mail Order - (three month supply) is \$45.00 for generic, \$75.00 for Formulary Brand, and \$115.00 for Non-Formulary Brand.

Enrollment Forms

Over the past few months, the Fund Office has mailed out enrollment forms with your monthly status reports. If you haven't mailed them in, please take a few minutes to complete these forms and return them to us so that we can make sure all of your information is up-to-date and correct. Please remember to report any changes to the fund office as soon as possible, such as: marriage, divorce, adding dependents, change of beneficiary, change of address, etc. Information is not shared between the Fund Office, Central Pension, and Local 181 Union Hall.

As a reminder, this information is not only to keep your records up to date in our office, but is also shared with our plan partners, Anthem and Caremark. If we are not notified of these changes, it could jeopardize whether a dependent is eligible and claims from being processed and paid.

You have also started receiving many of the yearly notices that the Fund Office is required by law to send. We always try to combine these mailings with your monthly status reports. Please take a few minutes to look over the notices.

Annual Compliance notice; a separate notice will be mailed out by the Fund Office. In compliance with the provisions of the:

- * Women's Health & Cancer Rights Act of 1998 is to inform you that your H & W Plan provides benefits for mastectomy related services including reconstruction and surgery to achieve symmetry between the breasts, prostheses and complications resulting from a mastectomy, including lymphedema. All plan provisions, such as deductible and co-insurance apply.
- * Newborn's and Mother's Health Protection Act of 1996 requires group health plans that offer maternity hospital benefits for mothers and newborns to pay for at least a 48-hour hospital stay for the mother and newborn following childbirth (or, in the case of cesarean section, a 96-hour hospital stay), unless the attending provider, in consultation with the mother, decides to discharge earlier.

We are here to answer your questions regarding eligibility and benefits. Feel free to contact us with any questions you may have. Our office hours are 8:00 a.m. to 4:30 p.m., CST, Monday through Friday. Our phone numbers are as follows:

Both the Lynnville and Boston Training Sites are greatly expanding the opportunity for training and certification of our members. Some recent additions are a GPS dozer and tower crane at the Boston Site and an overhead


